#### JCHA Monthly Meeting Minutes - October 11, 2023 Submitted by Secretary, Karen House

Vice President Debbie Walker called the meeting to order at 7:00 pm.

**Roll call of Board-** Vice President, Debbie Walker, Treasurer, Bruce House, Secretary, Karen House, Sunshine, Carol Dombrowsky were all present. President, Sabina Martin, Hospitality, Sandi Humphfres, and Member at Large, Julieana Evans were absent.

**Refreshments & Door Prize-** Thanks went to Karen House, Jill Mialkovsky, Deanne Gorman & Carol Dombrowsky for refreshments and to Laura Woolley, Carol Dombrowsky, Dianne Gorman & Debbie Walker for furnishing the door prizes.

Introduction of New Members and Guests- No new members or guests this month.

**September Meeting Minutes-** There were no corrections or additions to the newsletter. Motion was made, 2nd and approved to accept the September minutes as printed in the newsletter.

**Treasurer's Report-** Bruce House reported the club had a beginning balance in the checking account- \$2999.61; expenses \$1,002.00; income \$4,930.06. Ending balance in checking \$6,927.67; Joann Pool fund \$4,369.57; cash on hand \$25.00; Business Ownership Account \$8.69; for total cash assets of 11,330.93. No outstanding club related bills to hand in. Motion was made, 2nd and approved to accept the treasurer report.

Sunshine Report- Carol Dombrowsky reported that she sent cards to: Jill Mialkovsky for the loss of her horse, Bode. If anyone knows of a club member who could use an uplifting card, please contact Carol.

Ride JCHA Report- Karen House had no new awards to report this month.

#### Old Business:

**TATA Trot Horse Show & Trail Challenge- Oct 7-8:** Sabina Martin chaired this huge club event and with volunteer club member help, the TaTa Trot horse show and the new trail challenge went over smoothly!

Total horses for the horse show were 67 and 20 total horses for the trail challenge. Jami Kaptien was show judge.

Partial funds from the TaTa Trot show will be split between Asante and Riding Beyond receiving 25% each with the club keeping 50%. The final totals will be decided on at the November membership meeting. All show expenses are paid with the exception of the high point buckles which are approximately \$100 each.

A motion was made, 2nd and approved to repay Sabina Martin \$200.00 for the pizzas she furnished for lunch to the volunteers over the weekend.

**Christmas Parade- December 2:** Is held on the 1st Saturday of December, there has been no reported member interest in the club entering the parade, so it was decided not to enter this year.

**Christmas Party- December 9**: Debbie Walker reported the doors open at 5:15pm with dinner being served by 6:00pm. The choices of dinner may be prime rib, chicken breast or teriyaki chicken, not sure on dinner prices as yet, but could be around \$20 per dinner. A gift exchange, door prizes, toy/food drives will fill out the evening, club members and invited guests are welcome. Debbie asked if anyone has some sturdy boxes to use for the can foods and toys to please bring some. There is a time frame conflict of having the house band "The Gist" play, so Debbie will check with Penney Reed and her husband to play DJ music for us. Final party decisions will be made at the November membership meeting, a Christmas Party flyer and dinner registration form to be included in the November newsletter.

#### New Business-

**2024 Board of Directors** - Elections are coming up soon, Debbie Walker reminded everyone to consider running for an officer position on the board. Nominations will be accepted at the December membership meeting with voting at the January 2024 meeting.

**Other Equine Events-** The High Desert Chapter of the BCH recently installed 3 new two horse metal pipe corrals at Fourmile Lake Campground, the Sour Dough Chapter are still gathering funds to do their part in the corral improvements for next spring. There will be a total of 4 sites with new corrals.

**Greenway Clean Up-** There has been much activity in clean up along the Dean Creek Trail and the parking area near The Expo by the Trail Dust Saddle Club, they are in the process of contracting with the Jackson County Sheriff and the County to adopt the Greenway trails in keeping them clean of debris & garbage to encourage more use from horse trail riders. About 25 years ago JCHA installed a picnic table and hitching post along the trail, so once the adoption agreement is made it's possible that JCHA and other clubs can join in to help out in maintaining the trails, as the Jackson County Sheriff wants to see the trail area being ridden and enjoyed again as that's what it was built for. Micki Juardo offered to look into Jackson County SAR patrolling the area for safety as a community service.

**Open Trail Ride-** Debi Kubik is hosting an open trail ride, Oct 29 starting at 10:00am at the Dean Creek Trail near The Expo. The trail will be flagged along the Greenway bike/equestrian trail starting at The Expo end, parking will be in one of the dirt parking areas at The Expo between gates #5 & #6 in Central Point.
